

This article analyzes the codes of professional conduct in relation to the duties of confidentiality, loyalty, zealousness, and competence of court-appointed child advocates in child protection proceedings. It further demonstrates how many legislative regulations governing those appointments violate separation of powers because of state supreme courts inherent and/or plenary power over attorney regulation.
